The Five Divine Institutions

- Volition
- Marriage
- Family
- Human Society
- Nationalism

Volition or Individual Choice, Authority and Responsibility

- Volition began with the creation of the first man and woman. They were responsible to correctly exercise authority over their own choices Gen. 2:7, 15-25.
- The most important choice is presented to all men: whether or not to have a relationship with God. Everyone has the authority and responsibility to make that choice.

Volition or Individual Choice Personal Liberty

- We must have personal liberty to make personal choices.
- Many in this world do not have freedom of speech, or assembly, or to vote as we do in this country.
- But all normal people have freedom of thought and ultimately freedom to accept or reject the Lord Jesus Christ as their personal Lord and Savior.

Marriage and Family Authority and Responsibility

- Marriage is a covenant between a man and a woman.
- God delegated headship in marriage to the husband.
- The husband's authority in marriage is limited.

<u>Divine Institutions – Preserving the Human Race</u> (Continued)

 Both husband and wife are directly accountable to God – the husband for proper exercise of authority, the wife for proper submission to authority.

Marriage and Family Freedom

- The husband's authority may not usurp the wife's freedom.
- The wife must have access to spiritual resources.
- The man is responsible for her health and well-being.
- The man must provide household help when needed.
- Children's freedom must be restricted at first, then gradually granted as they display increasing capacity.

Marriage and Family Morality and Justice

- Both husband and wife are accountable to God for moral and just behavior.
- Immoral and unjust behavior in marriage and family has terrible consequences for all persons involved.
- There are many immoral actions in marriage and family, not just sexual: lying, deception, slander, violence, etc.

Marriage and Family Free Enterprise

- The husband is responsible to provide for wife and family within the sphere of free enterprise.
- This does not exclude the wife from participating in free enterprise Prov. 31:16, 24
- Children should be taught principles of free enterprise and be allowed to participate in it as appropriate to their age and development.

Marriage and Family Social Responsibility

• Since marriage is the basic social unit, both husband and wife are to exercise social responsibility toward each other.

<u>Divine Institutions – Preserving the Human Race</u> (Continued)

- Men need approval and respect; women need to feel loved, cherished and secure. 1 Cor. 7:3 commands husband and wife to fulfill each other's needs.
- A sense of social responsibility begins in childhood and is modeled by the parent's behavior.

Marriage and Family Internal and External Security

- Husband and wife must both have safety and security in marriage.
- There are threats external to the family, and there are threats internal to the family.
- Children must feel safe and protected—there must be stability in the family. Sinful behavior witnessed by children is often perpetuated by them into their own families.

Human Society

- An association of individuals and families that constitutes a living organism whose cells are families. Healthy families will make up a healthy society.
- Society's purpose is to provide mutual aid and cooperation to improve life for all its members.
- It should provide an environment of blessing that allows for the maximum development of human potential.

Human Society Authority and Responsibility

- In a working society there must be leaders and followers.
- Authority orientation begins in the family.
- Authority orientation continues in school, athletics, church, the military, and in the workplace.
- A society characterized by lack of authority orientation suffers overflowing divine discipline and cursing.

Human Society Liberty

- With freedom comes responsibility.
- Freedom without boundaries is chaos.
- A free society contains the seeds of its own destruction.

Divine Institutions — Preserving the Human Race (Continued)

• The prosperity of the USA has created a sense of entitlement among many of its citizens.

Nationalism

- God instituted nations during the Tower of Babel incident.
- God had commanded men to disperse into the earth.
- Men had one common language or way of communication. God scrambled their communication causing them to develop languages common only to their own tribes.
- The resulting inter-tribe conflicts caused them to separate and to move out into the earth as they were supposed to.
- Eventually people refined their grunts and gestures into languages specific to their own tribes—which eventually became nations.
- In this way God isolated people into groups in order to quarantine evil and keep it from infecting everybody. This has worked effectively for the last 6,000 years.
- With the advent of communication technology in the last 100 years we have seen an unprecedented surge of evil.

Nationalism Authority and Responsibility

- Authority in a nation is vested in a national government.
- The type or style of government varies greatly:
 - Dictatorships
 - Democracies
 - Monarchies
 - Constitutional Republics
 - Bureaucracies

Nationalism Liberty, Morality, and Justice

- The type of government and standard of living is a reflection of the norms and standards of the populace.
- A populace with respect for God and high morals generally has an enlightened government and high living standards.
- One with no respect for God and low morals generally has a repressive government and low living standards.

Nationalism Free Enterprise, Social Responsibility and Security

- Under repressive governments free enterprise is not free.
- Care for the poor is restricted.
- Security is weak or non-existent.
- There is often persecution of minorities & even genocide.
- The Gospel of Christ is suppressed, and Christians are persecuted or killed.
- Governments rooted in Divine Establishment principles provide maximum freedom for its citizens.
- A high sense of morality is the norm, and justice is fair.
- Travel is unrestricted, freedom of association, speech, activity, and worship is assured.
- Property rights are respected and sharing, and disposal of wealth is unrestricted.
